## **FINAL JUDGMENT**

BE IT REMEMBERED on the 10<sup>th</sup> day of November 2009, the Court entered its order in the above-styled cause granting judgment as a matter of law for the Defendant Rissie Owens, on the basis of her lack of personal liability under 42 U.S.C. § 1983, and there remaining no other defendants pending, the Court enters the following judgment:

IT IS ORDERED, ADJUDGED, and DECREED that the plaintiff Ray Graham TAKE NOTHING on his claims brought under 42 U.S.C. § 1983 against the defendants Rissie Owens and Stuart Jenkins in the above-styled cause.

IT IS FURTHER ORDERED, ADJUDGED, and DECREED that Defendants are required to pay Plaintiff's reasonable attorneys' fees in the amount of \$57,548.13 (FIFTY-SEVEN THOUSAND, FIVE HUNDRED AND FORTY-EIGHT DOLLARS AND THIRTEEN CENTS), and reasonable costs and expenses in the amount of \$18,236.80 (EIGHTEEN THOUSAND, TWO HUNDRED AND THIRTY-SIX DOLLARS AND EIGHTY CENTS). Plaintiff is entitled to post-judgment interest on the total award of \$75,784.93, running from the date on which this final judgment is entered.
