JOINT MOTION TO STAY LITIGATION

The Plaintiff Jonathan Paul Boyd and the Defendant R. Bob Mullins, Jr., M.D., in his official capacity as Commissioner of the Alabama Medicaid Agency, jointly move the Court to enter an order staying this litigation indefinitely and suspending all remaining scheduled dates and deadlines, including the deadline for expert reports, the deadline for filing potentially dispositive motions, the deadline for discovery, and the pretrial and trial dates. As grounds for this motion, the parties state the following:

- Defendant has recently filed a motion for leave to amend his previous answer, asserting that the discovery of previously undisclosed assets has caused the Alabama Medicaid Agency to question the Plaintiff's past, present, and future eligibility for the Medicaid program.  - 2. Plaintiff acknowledges that the issue of his eligibility for the Medicaid program must be resolved, but does not concede that he is not now eligible for Medicaid benefits.
 - 3. The parties agree that the interests of justice and judicial economy would be served by staying the present litigation while the issue of Plaintiff's past, present and future eligibility for Medicaid benefits is resolved through appropriate state proceedings.
