MODIFICATION OF STIPULATION

The parties, on April 24, 1990, entered into a stipulation to establish an agreed upon framework which would as expiditiously and inexpensively as possible lead to settlement of the pending litigation.

Certain modifications have been agreed upon by the various parties and the Central Committee established by and

between the Plaintiffs and Defendants pursuant to that stipulation.

In regards to the Central Committee, the Defendants have substituted the name of Dr. Audrey Cotherman for that of Lynn Simons under the functional area of Education. The parties have also agreed that there was no need for a seventh member on this Committee, at this time.

The Central Committee has agreed to meet at least monthly and have done so during the months of May and June and have scheduled meetings in both July and August.

The Central Committee has also agreed that Jeannie Kawcak and/or Joan Alexander of Protection and Advocacy may attend Central Committee meetings, and the State is free to invite Sherri Lovercheck to attend those negotiation sessions.

The Plans for Resolution have been somewhat modified by and between the parties previously, but the time table agreed upon on page 4 and 5 is to be adhered to from this day forward.

All the terms, conditions and agreements previously entered into the stipulation on April 24, 1990, are

incorporated in this Modification of Stipulation, the same as if fully set forth herein.
