STIPULATED AGREEMENT

The parties met with CAB on November 18, 1993 to discuss and resolve the status of the documentation process of the Consent Decree. This Stipulated Agreement is entered into for the purpose of documenting the current status of the terms, conditions, and obligations of the Consent Decree. The format for the documentation and transmittal process is outlined as shown in Attachments A and B and Exhibits I, II and III.

The items submitted under this process are to be weighed by the Court in determining compliance with the Consent Decree. The measure of whether there is compliance with the Consent Decree is a judicial decision. Nothing in this Stipulated Agreement is intended to waive or limit either party, at a later date, from raising the issues agreed to herein and in determining compliance with the Consent Decree.

The parties hereby agree that items will be transmitted in accordance with Exhibits I, II and III.

ATTACHMENT A

Documentation for Transmittal Process:

1. The State will submit items in transmittal format and send a copy of the Transmittal Form to CAB. (Exhibit I)
2. Within 14 working days of receipt, Protection & Advocacy will review the Transmittal Form and indicate agreement or non-agreement. (Exhibit II)
3. Copies of State Transmittal Form documents and P&A Response documents will be submitted by the State to CAB. Such documents will be maintained by CAB in an official Status file.
4. CAB will, within 14 working days, review the materials submitted, approve, invoke the dispute resolution process or indicate further action. When approved, there will be acknowledgement from CAB including appropriate signatures. (Exhibit III)
5. CAB will be responsible for submitting the official Status file to the Court.

ATTACHMENT B

Definitions:

For the purposes of Exhibits II and III, the definitions indicated below shall apply.

Agreement: An understanding of the parties regarding the status of Consent Decree items at a point in time, subject to re-opening of any subsequently disputed items based on newly discovered information or change in status.

Non-Agreement: Disagreement between the parties which shall be resolved by further cooperative action of the parties or through the already established dispute resolution process.
