## Citizens will offer more than 250 Talking ATMs in Massachusetts

Citizens collaborated with the Bay State Council of the Blind and the Disability Law Center (DLC) of Massachusetts to enhance existing plans for its New England-wide rollout.

The audio component of Citizens' Talking ATMs is heard when customers plug their headsets into the machines and listen to a series of audio prompts that guide them in conducting banking transactions electronically.
