Concomitant with the responsibility of the defendants in this regard, all attorneys who are members of the Bar of this court are admonished to use their best efforts to cooperate with the defendants to the end that their responsibilities as attorneys are fulfilled in such a manner as to be conducive to a minimum of inconvenience to the defendants;</p> <p>(b) Using any instrumentality against any inmate which might result in injury to said inmate, except in the case of self defense or where there is imminent clear and present danger of physical danger of physical violence by an inmate or inmates that cannot be otherwise restrained;</p> <p>(c) From the use of tear gas or deleterious chemicals against any individual inmate except in the most extraordinary circumstances and after approval in writing of the superintendent, or his duly authorized assistant, of the Virginia State Penitentiary;</p> <p>(d) From denying any inmate the use of mattresses and bedding as a form of punishment for such periods of time as may endanger the health of any said inmate;</p> <p>(e) That no inmate be placed in isolation or solitary confinement as punishment in such manner or for such a period of time as would be detrimental to this physical and mental health, as determined by a qualified, practicing Physician;</p> <p>(f) That all inmates shall have reasonably prompt access to the courts;</p> <p>(g) That all inmates be afforded such toilet articles and other necessities as required to alleviate any detriment to said inmates' health as determined by a qualified practicing physician;</p> <p>(h) From confining any inmate in a room or area which may be detrimental to this physical and mental health as determined by a qualified physician.</p>
