COME NOW the plaintiffs, above-named, by their attorney, G. MICHAEL SCHEURICH, and as and for their complaint against the defendant alleges as follows:

I. Parties.

1. The plaintiffs are minor school children, resident within the defendant school district, located primarily in Winnebago County, Illinois, by their parents and next friends, and an unincorporated association comprising some or all of the aforesaid parents.

2. The defendant is a special charter school district, operating elementary and high schools primarily in the City of Rockford, Illinois and surrounding areas in Winnebago and Boone Counties, and is a municipal corporation and body politic and a subdivision of the State of Illinois.

II. Jurisdiction.

- 3. The plaintiffs bring this action to redress, rights, privileges and immunities guaranteed by the Constitution and laws of the United States and of the State of Illinois, particularly the right to equal educational opportunities free from racial discrimination.
- 4. The defendant, SCHOOL DISTRICT, has adopted and is implementing a program of student assignment to schools within the district based on the race of the student to be so assigned. This program of racially determined school assignment is commonly known as "controlled choice" and defendant, SCHOOL DISTRICT, purports to implement the plan of controlled choice pursuant to certain decrees and orders entered by the Federal District Court for the Northern District of Illinois in the case captioned People Who Care v. Rockford Board of Education School District No. 205.
- 5. Jurisdiction of this court is found specifically in 28 U.S.C. 1331, 1334(a)(3), and (a)(4), authorizing suit under 42 U.S.C. 1983 and 1988, and also 20 U.S.C. 2201 and 2202.

III. General Allegations.

6. Despite there being openings for attendance, the plaintiffs have been denied access, by the defendant, to schools conducted by the defendant, on the basis of the race of each such plaintiff, as follows:

- 7. Without judicial intervention, the defendant will continue to implement the program of controlled choice, thereby denying student's preferred class and school assignments impermissibly based on the race of the student.
- 8. The financial burden to the defendant of relief herein is slight when compared with the deprivation of constitutional rights suffered by the plaintiffs.

WHEREFORE, it is respectfully prayed that this court:

A. Grant such preliminary and permanent injunctions as may be necessary to enjoin the defendant from engaging in impermissible racial discrimination not justified by compelling state interest or required to redress racial segregation caused by a constitutional violation by the defendant.
