The Proposed Settlement Classes that the Court conditionally certified in its Preliminary Order are hereby finally certified for settlement purposes under Fed. R. Civ. P.23 (b)(2) and (3). The Damages Settlement Class and Injunctive Settlement Class are comprised as stated in the Prelimianry Approval Order. 2. Adequacy of Representation. The Court fully and finally confirms the appointment of the Class Representatives and Class Counsel as stated in its Preliminary Approval Order.
