#### INMATE RIGHTS AT INSTITUTION DISCIPLINE COMMITTEE HEARING

As an inmate charged with a violation of institution rules or regulations referred to the Institution Discipline Committee for disposition, you have the following rights:

- The right to have a written copy of the charge(s) against you at least 24 hours prior to appearing before the Institution Discipline Committee;
- The right to call witnesses and present documentary evidence in your behalf, provided institutional safety would not be jeopardized;
- The right to be present throughout the Institution Discipline Committee hearing except during Committee deliberations and except where institutional safety would be jeopardized;
- 4. The right to be advised of the Institution Discipline Committee's decision, the facts supporting the Committee's decision, except where institutional safety would be jeopardized, and the committee's disposition in writing; and,
- 5. The right to appeal the decision of the Administrative Remedy Procedure to the Chief Executive Officer (Warden) within 30 days of notice of the Committee's decision and disposition.
