## ORDER WITH REGARD TO SCHOOL DISTRICT ELECTION ISSUES

ROSZKOWSKI, District Judge.

\*1 Various issues concerning the process for election of Board Members of the Defendant School District ("District") have been before the Court since May 31, 1991, when the District filed a Petition for Instructions, wherein it sought a judicial resolution of the alleged invalidity of the electoral sub-district boundaries adopted by the District on May 21, 1991.

In an Order entered September 12, 1991, this Court set forth the background of these issues, and made Findings and Conclusions concerning the electoral issues, which will not be reiterated here.

The September 12 Order established a process for resolution of the two final electoral issues: the precise electoral sub-district boundaries, and the detailed schedule of election events surrounding the School Board election now scheduled for March 17, 1992.

## A. Electoral Sub-District Boundaries

In accordance with the September 12 Order, Plaintiffs submitted on September 23, 1991, a proposed set of sub-district boundaries delineated on a map ("Plaintiffs' Proposed Map"). In a contemporaneous Submission, Plaintiffs represented that their Proposed Map conforms to the requirements of Section 2 of the Voting Rights Act and Section 9–22 of the Illinois School Code, and to the more specific criteria set forth in the September 12 Order.

Since September 23, the Plaintiffs' Proposed Map has

been available for public inspection at the School District offices and in the office of the Clerk of this Court. In addition, after providing at least seven days' notice, the District held a public hearing on October 2, 1991, and the District has reported that no objections to the Plaintiffs' Proposed Map were voiced at that hearing.

In addition, from September 23 through October 17, the Proposed Map has been reviewed by the various Election Authorities who have the responsibility to conduct the School District's elections. This review has also included a set of detailed street descriptions of the electoral sub-districts, which was transmitted by Plaintiffs on September 24 to the Election Authorities and the District.

In response to the request of the Election Authorities, Plaintiffs have agreed to make certain minor corrections in their Proposed Map and in the corresponding street descriptions, in order to minimize the number of splits of precincts. These changes were described in a letter dated October 8, 1991, from Mr. Howard to Messrs. Enichen, Scariano, and Schmidt, a copy of which was filed with the Clerk of this Court. Each of these changes involves only a very small number of voters (ranging from about three voters to less than ten), and each change involves only a very small amount of territory. Accordingly, these changes do not affect the geographic, demographic, or legal characteristics of Plaintiffs' Proposed Map.

Plaintiffs have submitted to the Court on October 18, 1991, a Final Electoral Map and corresponding street descriptions, which incorporate the minor changes made since September 23, 1991. Plaintiffs have requested in open court on October 18, 1991, that the Court approve the Final Map and corresponding street descriptions and order that these electoral sub-district boundaries be used for the March 17, 1992 School Board election, and for future School Board elections until further order of this Court.

\*2 The District, having had the Plaintiffs' Proposed Map under consideration since September 23, and having been informed of the minor changes made at the request of the Election Authorities, has stated in open court on October 18, 1991, that it does not object to the Final Map and street descriptions, nor to the entry of an Order as requested by Plaintiffs. The Election Authorities, by their counsel, have also informed the Court on October 18 that they have no objection to the Plaintiffs' Final Map and the corresponding final street descriptions.

#### B. Election Schedule

This Court's Order of September 12 established a date of

March 17, 1992, for the election of Board Members for the District, and required the parties and the Election Authorities to submit a revised calendar for all events related to that election. Such a revised calendar has been submitted to the Court by the parties and the Election Authorities.

The parties and the Election Authorities have pointed out that the last date for candidates to file nomination papers is December 16, 1991. Therefore, from the date of this Order, candidates would have approximately 52 days to circulate petitions, rather than the 90 days which would normally be applicable. This modification, of course, results from the time required for judicial resolution of the various electoral issues. The parties and the Election Authorities have urged, and this Court concurs, that this modification does not represent a significant disadvantage to potential candidates, particularly since the required number of signatures is modest.

#### C. Conclusion

Accordingly, the Court hereby orders:

- 1. The Final Map of electoral sub-district boundaries submitted by Plaintiffs on October 18, 1991, and the corresponding final street descriptions attached hereto, are hereby approved, and the District and the Election Authorities shall use those electoral sub-district boundaries for the election of Board Members of the District to be held on March 17, 1992, and for future elections of Board Members until further order of this Court.
- 2. The Calendar for Revised Non-Partisan Election of the Rockford School District No. 205, submitted jointly by the parties and the Election Authorities and attached hereto, is hereby approved, and shall be used by the District and the Election Authorities in conducting the election of Board Members scheduled for March 17, 1992.

## THURSDAY, DECEMBER 26, 1991

Last day lottery shall be conducted by the local election official when 2 or more petitions are received simultaneously for the same office as of the opening hours of filing period.

#### THURSDAY, JANUARY 16, 1992

Last day candidates may file withdrawal of nomination papers in the office of the local election official.

#### WEDNESDAY, JANUARY 22, 1992

Last day for local election official to certify offices and candidates to the election authority.

## SATURDAY, FEBRUARY 1, 1992

Last day for the election authority to have in his office a sufficient number of ballots printed and available for mailing to persons in the United States Service or their spouse or dependents and citizens of the United States who are temporarily residing outside the territorial limits of the United States.

# THURSDAY, FEBRUARY 6, 1992

For the purpose of issuing pollwatcher credentials, the last day for civic organizations and proposition proponents or opponents to register their names and addresses of their principal officers with the proper election authority.

## THURSDAY, FEBRUARY 6, 1992

First day for registered voters presently within the confines of the United States who expect to be absent from their county of residence on election day to make application by mail or in person to the election authority for an official ballot.

## SUNDAY, FEBRUARY 16, 1992

First day for election authority to publish notice of Special School District Election and notice of referenda. (May include a list of precinct polling place addresses.)

## TUESDAY, FEBRUARY 18, 1992

Last day for registration or transfer of registration in the office of the election authority.

## WEDNESDAY, FEBRUARY 26, 1992

Last day for election authority to publish notice of Special School District Election and notice of referenda. (May include a list of precinct polling place addresses.)

# TUESDAY, MARCH 3, 1992

Last day for election authority to have pollwatcher credentials available for distribution.

## THURSDAY, MARCH 12, 1992

Last day automatic tabulating equipment may be tested.

## \*7 THURSDAY, MARCH 12, 1992

Last day for election authority to receive application by mail from any registered voter presently within the confines of the United States, who expects to be absent from his county of residence on election day and the last day for the election authority to mail such ballot.

## THURSDAY, MARCH 12, 1992

Last day for the election authority to publish the specimen ballot label pages, as near as may be, in the form in which they will appear on the official ballot labels on election day.

## FRIDAY, MARCH 13, 1992

Last day (by 5:00 p.m.) a person may file a notarized declaration of intent to be a write-in candidate with the proper election authority.

# MONDAY, MARCH 16, 1992

Last day for election authority in counties having a population under 500,000 to publish a list of all the nominations that are to be voted for at the Special School District Election.
