ORDER

AND NOW, this 29th day of April, 2011, it appearing that by Order dated October 8, 2010, this matter was certified as a Class Action pursuant to Federal Rules of Civil Procedure 23(a) and 23(b)(2), and it appearing that the parties have entered into a Settlement Agreement, and it further appearing that pursuant to Federal Rule of Civil Procedure 23(e) this Court is required to give notice to the members of the class of this proposed settlement and to approve the settlement after hearing, it is **ORDERED** as follows:

1. The Settlement Agreement which is attached hereto as Exhibit A is preliminarily **APPROVED**.
2. A Hearing on the Fairness of the Settlement Agreement is scheduled for June 15, 2011, at 10:00 a.m. in Courtroom 8A, United States Courthouse, 601 Market Street, Philadelphia, Pennsylvania.
3. On or before May 10, 2011, Counsel for Plaintiffs shall give notice to all named Plaintiffs in the form attached hereto and numbered Exhibit B.
4. On or before May 10, 2011, City Defendants shall publish notice of the hearing in the Philadelphia Inquirer and the Philadelphia Daily News. On or before May 10, 2011 City Defendants shall also post the Notice of Class Action Settlement (Exhibit B) in every housing unit and in every law library in the Philadelphia

Prison System. Proof of publication shall be submitted at the hearing on June 15, 2011.

5. On or before May 10, 2011, Counsel for Plaintiffs shall send a copy of this Order with Exhibits to Counsel in the Consolidated Prison Overcrowding Actions as follows:
