MEMORANDUM IN SUPPORT OF MOTION FOR UNITARY STATUS IN THE AREAS OF EMPLOYMENT AND ASSIGNMENT OF PRINCIPALS AND ASSISTANT PRINCIPALS AND THE EMPLOYMENT OF COUNSELORS

MAY IT PLEASE THE COURT:

Defendant Tangipahoa Parish School Board is entitled to the entry of a judgment declaring it unitary in the areas of employment and assignment of school-site administrative personnel comprised of principals and assistant principals, and the employment of counselors. The school board submits a) there has been full and satisfactory compliance with the Orders of the court with respect to school-site administrative hiring and the assignment of school-site administrators on a race neutral basis, and the employment of counselors; b) further judicial supervision in these areas is no longer necessary or practicable to assure achievement of compliance with other facets of the court's judgment in Record Document No. 876 or other Orders of the court; and c) the school board has demonstrated and continues to demonstrate to the public and to those on whose behalf the lawsuit was filed its good faith commitment to the whole of the court's Orders and to those provisions of the law and the Constitution that were the predicate for federal judicial intervention in the first instance in the areas of school-site administrative hiring and assignments.

THE PRESENT MOTION IS PROPERLY BEFORE THE COURT

The present motion is properly before the court. Both controlling federal precedents and this court's Orders authorize the filing of the present motion.

"A federal district court in a school desegregation case has the discretion to order incremental or partial withdrawal of its supervision and control." *Freeman v. Pitts*, 503 U.S. 467, 489, 112 S. Ct. 1440, 118 L. Ed.2d 108 (1992). "While retaining jurisdiction over the case, the court may determine that it will not order further remedies in areas where the school district is in compliance with the decree." *Freeman*, 503 U.S. at 490-91.

The exercise of a federal district court's discretion to order incremental or partial relinquishment and termination of its supervision must be made in a manner consistent with its equitable powers, and the district court must consider

Whether there has been full and satisfactory compliance with the decree in those aspects of the system where supervision is to be withdrawn; whether retention of judicial control is necessary or practicable to achieve compliance with the decree in other facets of the school system; and whether the school district has demonstrated, to the public and to the parents and students of the once disfavored race, its good faith commitment to the whole of the court's decree and to those provisions of the law and the constitution that were the predicate for judicial intervention in the first instance.

Freeman, 503 U.S. at 491. Stated differently, "[t]he District Court should address itself to whether the Board ha[s] complied in good faith with the desegregation decree since it was entered, and whether the vestiges of past discrimination ha[ve] been eliminated to the extent practicable. Board of Education of Oklahoma City v. Dowell, 498 zi/D/ 237. 249-50. 111 S. Ct. 630, 112 L. Ed.2d 715 (1991).

Moreover, this court's Orders authorize the present motion. Paragraph 19 of the Order found in Record Document No. 876 provides as follows:

With respect to school site administrators, the school district may move the court for a declaration of unitary status when compliance is achieved with applicable legal requirements pertaining to the non-discriminatory assignment of administrative personnel. For purposes of this Order, "school site administrative personnel" means principals and assistant principals.

The court's Order found in Record Document No. 866 provides that at least 40 percent of school-site administrators shall be black with a goal of approximating the percentage of black school-site administrators with the percentage of black students enrolled in the school system. These requirements have now been achieved. Pursuant to the Order, the hiring procedures "shall terminate at such time as the diversity goals outlined above are met."

Paragraph 20 of the Order found in Record Document No. 876 requires that the percentage of black teachers be increased "to a level approximating the percentage of black students enrolled in the school system as of the date of court approval of this Order." "Teacher" is inclusive of counselors. See Paragraph 16 of the Order in Record Document No. 876. The percentage of black students in the school system as of the date of the Order was 47.7 percent.

RELINQUISHMENT OF JUDICIAL SUPERVISION IS MANDATED WHERE A SCHOOL SYSTEM IS IN COMPLIANCE WITH THE CONSTITUTION AND ORDERS OF THE COURT

Federal judicial supervision over the facets of the operation of a school system was never intended to "extend beyond the time required to remedy the effects of past intentional discrimination." *Dowell*, 498 U.S. at 248. Indeed, "[f]rom the very first, federal supervision of local school systems was intended as a temporary measure to remedy past discrimination." *Id.*, at 247. The end purpose of federal judicial supervision was, and remains, "to remedy the violation and in addition to restore state and local authorities to the control of a school system that is operating in compliance with the Constitution." *Freeman*, 503 U.S. at 489. It is submitted that this is necessarily the case because the return of "schools to the control of local

authorities at the earliest practicable date is essential to restore their true accountability in our government system." *Id.*, 503 U.S. at 489; see also, *Dayton Board of Education v. Brinkman*, 433 U.S. 406,410, 97 S. Ct. 2766, 53 L. Ed.2d 851 (observing that "local autonomy of school districts is a vital national tradition").

In short, once a school system comes into compliance with the Constitution and the orders of the court there is no longer a basis to support continuing federal judicial supervision. This necessarily follows because "[a] remedy is justifiable only insofar as it advances the ultimate objective of alleviating the initial constitutional violation[,]" and because "judicial powers may be exercised only on the basis of a constitutional violation[,]" *Freeman*, 503 U.S. at 489; *Swann v. Charlotte-Mecklenburg Board of Education*, 402 U.S. 1, 91 S. Ct. 1267, 28 L. Ed.2d 554 (1971).

THE SCHOOL SYSTEM HAS COMPLIED WITH THE COURT'S ORDERS

The school system has made progress since March 2010 to increase the number and percentage of black principals, assistant principals, and counselors.

Black principals:

In March 2010 black principals accounted for 35.1 percent of the principals employed by the school system. Today, 42.4 percent of principals employed by the school system are black. The percentage of white principals has declined from 64.9 percent in March 2010 to 57.6 percent today. Exhibit "A" shows the name, race, and school assignment of principals during School Year 2009-2010. Exhibit "B" shows the name, race, and school assignment of principals for the current school year.

Black assistant principals:

Similarly, the percentage of white assistant principals has declined from 67.9 percent in March 2010 to 54.5 percent today. In March 2010, there were ten black assistant principals. Today, black assistant principals number 14, or 43.7 percent, of the assistant principals in the employ of the school system. Exhibit "C" shows the name, race, and school assignment of assistant principals during School Year 2009-2010. Exhibit "D" contains the same categories of information for assistant principals for the current school year.

In March 2010, four black principals were assigned to racially identifiable white schools.

Today, eight black principals are assigned to racially identifiable white or desegregated schools.

Four white principals were assigned to racially identifiable black schools as of March 2010.

Currently, seven white principals are assigned to racially identifiable black schools.

Black counselors:

In School Year 2009-2010, four of 12 counselors were black. As of the commencement of the current school year, six of the 12 counselors employed by the school system were black. One of the black counselors resigned in January 2013. Exhibit "E" shows the name, race, and school assignment of counselors employed during School Year 2009-2010. Exhibit "F" shows the current name, race and school assignment of counselors employed by the school system.

THE SCHOOL SYSTEM HAS AN INCENTIVE NOT TO REGRESS UPON A DECLARATION OF UNITARY STATUS

In pertinent part, the court's Order found in Record Document No. 866 provides as follows:

Upon expiration of this policy, the parties and the court Compliance Officer shall conduct a bi-annual review of the percentage of administrators and supervisors employed by the school system in each category to assure that employment gains are maintained to the extent practicable.

The "policy" with respect to principals and assistant principals has now expired based upon the

school system's compliance with the court's Order. Should either plaintiffs or the Court

Compliance Officer have reason to believe the school system is intentionally discriminating

against future black applicants seeking principal or assistant principal positions based upon their

race, they may seek to re-impose remedial orders.

THE ORDER IN R. DOC. NO. 866 AFFECTING

OTHER ADMINISTRATIVE AND SUPERVISORY POSITIONS REMAINS IN EFFECT

The "policy" in the Order in Record Document No. 866 addressing administrative and

supervisory positions other than those of principals and assistant principals will remain in effect

upon a declaration of unitary status in the areas of principal and assistant principal hiring and

school assignments.

CONCLUSION

The school system is in compliance with Orders of the court (R. Doc. Nos. 866 and 876

at Paragraphs 19 and 20) and is entitled to a declaration of unitary status and relinquishment of

judicial supervision. There no longer exists a basis for continuing judicial supervision in the

areas of employment and assignment of principals and assistant principals and employment of

counselors.
