[296-1], within thirty (30) days; defendants may invoke any applicable privilege. Defendants' motion to continue trial and related deadlines, docket no. 269 , and plaintiffs' motion to extend certain deadlines, docket no. 304 , are each GRANTED in part and DENIED in part. The trial date is continued from September 12, 2016, to November 7, 2016. The Court indicated that the parties should be prepared to start trial as early as November 1, 2016. The Court will issue a separate scheduling order. The parties estimate that trial will require between 9 and 12 days. Plaintiffs indicate that they do not intend to call as witnesses at trial, or submit in connection with dispositive motions or responses thereto any declarations from, Mirta Laura Contreras, Ann Herrera, or Jennifer Lissette Anzardo. Plaintiffs, however, wish to call as witnesses Blaine Bookey, Rebekah L. Fletcher, and Daniel J. Sharp. As to each of these three individuals, defendants may take a three-hour deposition. Defendants may also propound ten (10) additional written discovery requests, including all subparts, in any combination of requests for admissions, requests for production, or interrogatories, within ten (10) days. Defendants may depose either M.A.M. or Rosa Pedro, but not both individuals. Discovery shall be completed by August 8, 2016. The parties shall confer and provide a joint status report prior to the pretrial conference concerning the parties' views about whether experts may provide direct testimony via declaration and offer live testimony at trial only through cross-examination and redirect.
