Pursuant to the order of this Court dated June 1, 1967, in the above entitled cause, the defendants submit the attached report.

Supplementing the attached report by way of explanation, we respectfully show as follows:

1. No student exercising a choice to attend a school predominantly of another race has been denied his choice.
2. Exhibit "A" shows a total of 182 students of both races denied admission because of overcrowding at the end of the choice period. At that time, April 30, 1967, 436 students had chosen to attend a school predominantly of another race.
3. Exhibit "B" shows a total of 34 students of both races whose choices were denied because of overcrowding. These were first choices made after the choice period.
4. Exhibit "C" shows choices as of June 1, 1967, the date selected by the defendants as the most current one possible for this report due June 7, 1967. As of June 1, 1967, 488 students have chosen to attend a school predominantly of another race.
