PLAINTIFF'S FOURTH SET OF INTERROGATORIES AND ACCOMPANYING REQUEST FOR PRODUCTION OF DOCUMENTS

Plaintiff United States, pursuant to Rule 26, 33 and 34, F.R. Civ.P., requests that Spring Branch Independent School District, et al. (SBISD), respond within thirty (30) days by answering under oath the following interrogatories and producing the requested documents at the office of the United States Attorney, 3rd Floor, Federal Building, Houston, Texas, or at such other place as may be jointly agreed upon by counsel.

Interrogatory No. One

For each school year since September 1965, state the number of persons, by race, who were assigned to SBISD as student teachers during that school year, and for each person

who has been assigned to SBISD as a student teacher, provide that person's name, race, the basis for the racial identification, the college or university attended by the student, the period of assignment as a student teacher, and the SBISD school to which the person was assigned as a student teacher.

Interrogatory No. Two

Identify each college or university from which SBISD has accepted students for assignment as student teachers in the period since January 1, 1965, and for each school identified provide the following information:

- (a) State the year in which SBISD first entered into an agreement regarding the acceptance of student teachers from that college or university;
- (b) For each school year since September 1965, state the number of student teachers assigned to SBISD from that college or university;
- (c) State whether SBISD ever terminated that relationship with the college or university, and if so, state the date and the reason for termination, and identify by name and title all persons with knowledge thereof and identify by name and location, all documents relating to the termination, with the name, address and title of each person having custody of each document.

Interrogatory No. Three

State whether SBJSD has ever entered into an agreement with Texas Southern University (TSU) or Prairie View University regarding the acceptance by SBJSD of student teachers from those schools.

Interrogatory No. Four

If the answer to Interrogatory No. Four is affirmative for either TSU or for Prairie View University, state separately for each school to which the answer is affirmative:

- (a) The date on which an agreement to accept student teachers was entered;
- (b) All persons(s), by name, most recent address/title, and employer, who were involved in any way in the initiation and/or consummation of the decision to enter into agreement;
- (c) The name, address, race, period of assignment and school to which assigned for each student from those schools assigned to SBISD as a student teacher;
- (d) Whether, at any time after initiation of the agreement, the agreement was terminated, and, if so, set forth the date of and reason for termination, and the name, most recent address, title and employer of each

person involved in any way in the decision to terminate the agreement, and the title, location of each
document relating to that and the name, address and
title of each person having custody of each documents; and

(e) The name, address and title of each person, or if a document, the title, location of each document, with the name, address and title of the person having custody of each document, which is the source of information provided in response to this interrogatory.

Interrogatory No. Five

For each school to which the answer to Interrogatory No. Three is negative, set forth separately for each such school the reason why no such agreement has been entered into, and the name, address and title of each person, or if a document, the title, location of each document, with the name, address and title of the person having custody of each document, which is the source of information provided in response to this interrogatory.

Interrogatory No. Six

Identify the documents attached hereto and identified as Attachments A and B, and with respect to each:

- (a) Identify by name, location and name and title of custodian, the file in which the original of this document is maintained by SBISD;
- (b) State the meaning of the numbers ("1981" and "19821986" respectively) written on the top of document,
 identify the person who placed those numbers on the
 document, and state the purpose for which those
 numbers were placed on the document; and
- (c) If the numbers identified in (b) above refer to years in which the documents were in use, state the basis for that determination, and identify the person who made that determination.

Interrogatory No. Seven

With respect to the document attached hereto and identified as Attachment C,

- (a) Identify the file in which the original of that document is maintained, including the name, location, and name and title of the custodian of that file;
- (b) Identify that portion of plaintiff's request to produce to which Attachment C was a partial response;
- (c) State the identification of the person who prepared the original of Attachment C;
- (d) State the purpose for which Attachment C was prepared and the year in which it was prepared;

- (e) State whether any or all of the persons listed on Attachment C are black, and if so, state which persons SBISD believes to be black and the basis for that response; and
- (f) State whether any or all of the persons on Attachment C were applicants for teaching or other professional positions with SBISD, and if so, identify which were applicants, the year in which they applied and the basis for those responses.

Interrogatory No. Eight

Attachment D hereto was provided to plaintiff SBISD and identified in depositions of SBISD personnel as, <u>inter alia</u>, a summary of the number of applicants, by race and sex, who were interviewed at the main office of SBISD for professional and paraprofessional positions during the time periods shown on Attachment D.

- (a) State whether the information on Attachment D reflects the number of persons interviewed at the main office of SBISD for professional and paraprofessional positions in the period shown on that attachment (August 1983 July 1984);
- (b) State whether a similar report document exists, covering any other period since January 1, 1965, for

persons interviewed for professional and/or paraprofessional positions at the main office of SBISD. If so, identify the time periods covered by each such document, and the location and the person, by name, address and title, who has custody of each such document;

(c) State whether a similar report document exists covering any period since January 1, 1965, for persons seeking professional or paraprofessional positions with SBISD who were interviewed at a location other than at the SBISD main offices, and if so, set forth the periods for which such reports exist, and the person, by name, address, and title who has custody of each such report.

Interrogatory No. Nine

State whether tape recordings have been made of meetings of the Board of Trustees of SBISD at any time since January 1, 1965.

Interrogatory No. Ten

If the response to Interrogatory No. Nine is affirmative set forth

(a) The time period during which such recordings have been made.

- (b) The date of each meeting for which a recording exists, and the present location, including the name, address and title of the custodian, of each such tape recording.
- (c) For each such tape recording made which no longer exists, or on which material has been modified or deleted, set forth the date of the meeting recorded on the tape, the date on which such modification, deletion, or destruction occurred, and the reason for the modification, deletion or destruction of the tape.
- (d) State whether transcripts exist of the proceedings at any meeting of the SBISD Board of Trustees held since January 1, 1965, and, if so, identify the date of each such meeting, and the location and custodian of each such transcript.

Interrogatory No. Eleven

Attachment E hereto has been identified in deposition of SBISD employees as containing, <u>inter alia</u>, a tentative list of colleges and universities at which SBISD would conduct recruitment visits during the 1983-84 school year. Please state which of the schools listed on the tentative recruitment schedule for Spring 1984 were not in fact visited at that time by SBISD, and

for each such school, set forth the reason the trip was not made, and identify by name, address, title and employer, each person who would have information about the scheduled trip and/or its cancellation.

Interrogatory No. Twelve

Attachment F hereto has been provided to plaintiff by SBISD and identified in depositions of SBISD employees as containing, inter alia, a listing of schools scheduled for recruitment visits by SBISD in the 1985-86 school year. Please state which of the schools listed on that recruitment schedule were not visited at that time by SBISD and for each school district which was not visited, indicate the reason the trip was not made, and identify, by name, address, title and employer, each person who would have information about the scheduled trip and/or its cancellation.

Request for Production No. One

All records, correspondence to or from SBISD, agreements, memoranda, notes, memoranda of telephone conversations and other documents created in the period since January 1, 1965, which relate in any manner to the assignment of students from TSU or Prairie View to SBISD as student teachers, to establishing or to the possibility of establishing an arrangement between either of those schools and SBISD for the assignment of

students as student teachers, or to the termination of any such arrangement, and all other documents identified in response to Interrogatories Nos. Two, Four and Five of Plaintiff's Fourth Set of Interrogatories.

Request for Production No. Two

All records, correspondence, memoranda and other documents relied upon in providing the responses to Interrogatory No. Seven of Plaintiff's Fourth Set of Interrogatories.

Request for Production No. Three

All documents identified in response to Interrogatory No. Eight (b) and (c), of Plaintiff's Fourth Set of Interrogatories.

Request for Production No. Four

All tape recordings and transcripts identified in response to Interrogatory No. Ten of Plaintiff's Fourth Set of Interrogatories.
