Dear Mr. Rasnick:

After our meeting with the Board on August 14th, Sheriff and I contacted Deputy Sheriff Clifford with regard to your compromise offer in this case.

You are hereby advised that Mr. Boyd and the Sheriff have accepted your proposal, as follows: Mr. Boyd will be reclassified from a class 7 (sargeant) to a class 8 (lieutenant) on your salary scale for sheriff's departments. In addition, Mr. Boyd's salary for the 1981-82 fiscal year will be set at \$15,991.00. This pay increase, will, of course, be made retroactive to July 1, 1981.

Upon receipt of confirmation of this arrangement from your office, Sheriff Williams has advised me to dismiss the action which was previously filed on his behalf against the Compensation Board.

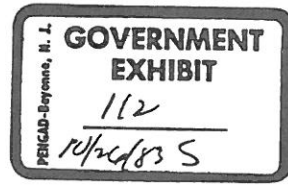

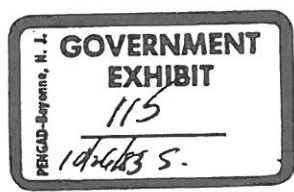
