So the City does not save itself any burden by a bifurcation here and no judicial efficiencies are gained. As to the merits, this is not a run—of—the—mill Monell claim based on excessive force or wrongful arrest. The allegation here is that the City sanctioned the use of a facility, not a police station, to detain suspects without charges and without access to counsel or families, used coercive tactics during interrogations, and sanctioned a code of silence.
