In other words, the Court will uphold, as unopposed, Defendant's arguments that its search was adequate, it has	08/22/2016		2016, and Plaintiff's Opposition was due on July 28, 2016. See Minute Order of June 1, 2016. As Plaintiff has failed to oppose Defendant's Motion, the Court will treat the arguments in the Motion as conceded under LCvR 7(b). In other words, the Court will uphold, as unopposed, Defendant's arguments that its search was adequate, it has produced all non–exempt portions of responsive records, and it has properly withheld material pursuant to the statutory exemptions. The Court thus ORDERS that the 14 Motion is GRANTED. A separate Judgment will issue. Signed by Judge James E.
