SUMMARY AND ANALYSIS
OF TERRELL COUNTY JURY RECORDS

INTRODUCTION

The following summary and analysis of records of the Terrell County Superior Court and the tax collector's office of Terrell County, relating to the selection of jurors in Terrell County is submitted to the Court as an aid to assist the Court in deciding the issues in this action.

Part I gives the statistics by race and sex of the number of persons placed on the jury rolls for Traverse and Grand Jury duty in Terrell County from 1944 through 1966. These statistics were derived from the Jury Roll Book of the Terrell County, Georgia, Superior Court, which records the names of persons placed by jury commissioners in the Traverse and Grand Jury boxes. Race of persons was determined by comparing the names on the Jury Roll with the names of persons on the Tax Digests of Terrell County for the years 1944 through 1966. Sex of persons was derived by classifying all persons listed on the Jury Rolls with female first names, Miss, and Mrs. as females. All persons listed on the Jury Rolls with initials for first and middle names were considered to be males.

Part II statistically presents a count by race and sex of the 1966 Tax Digest of Terrell County. This Tax Digest grouped Negroes and white persons separately.

Part III charts the names of persons placed on the Grand and Traverse Jury Rolls from 1944 through 1966, and the number of times each person was placed on the Jury Rolls.

These charts were constructed from the names of persons on the Traverse and Grand Jury Rolls as recorded in the Jury Roll Book of Terrell County, Georgia. Additionally, Part III charts the names of persons actually drawn to serve on Grand Juries between 1956 and 1966. This chart was constructed from the names of persons drawn for Grand Jury duty as listed in the Minute Books of the Superior Court of Terrell County, Georgia.

PART III

A. The Pool of Traverse Jurors

From 1944 through 1964, the pool of jurors in Terrell County consisted of only white males. During this twenty year period the jury rolls were revised eleven times, and a total of 6867 names were placed on the traverse jury rolls. An analysis of those rolls shows that the names of only 1662 persons appear. Of these, 631 (comprising 9.5% of the total population over 21 in Terrell County) appeared on the jury rolls 5 or more times during this period. These 631 persons, when multiplied by the number of times their names appear on the rolls, account for 72.3% of the total of 6867 names on the traverse jury rolls between 1944 and 1964. 68.8% of the persons placed on the 1966 traverse jury roll had been on previous traverse jury rolls.

Chart I shows the names of all persons on the traverse jury rolls between 1944 and 1966, and the years in which they were selected. This chart was derived from the names appearing in the Jury Roll Book of Terrell County. Those whose names are followed by an asterisk are identified in the Tax Digest of Terrell County as Negroes. The periods during which Negroes appeared on the rolls are indicated on the chart by cross-hatching. The periods during which white persons appeared on the rolls are indicated by blacking in the spaces.

In some cases, persons' names appeared differently in the Tax Digest and on the jury rolls. Where more than one variation of a name was used, the less frequently used variations are indicated in parenthesis after the person's name.

B. The Pool of Grand Jurors

Between 1944 and 1964, 2598 names, all white males, were placed on the grand jury rolls. An analysis of those rolls shows that the names of only 731 persons appear during this twenty year period. Of these, 222 persons (comprising 3.4% of the total population over 21 in Terrell County) appeared on the grand jury rolls 5 or more times between 1944 and 1964. These 222, when multiplied by the number of times their names appear on the rolls, account for 62.7% of the total number of 2598 names on the grand jury rolls between 1944 and 1964. 60.4% of the persons on the 1966 grand jury roll had been on previous grand jury rolls.

Chart J shows the names of all persons on the grand jury rolls between 1944 and 1966, and the years in which they were selected. It follows the same form as Chart I.

C. Persons Drawn For Grand Jury Duty

Between the summer of 1956 and the summer of 1966, ^{1/} 781 names were drawn from the grand jury rolls for service on grand juries. An analysis of these rolls shows that the names of only 348 persons (comprising 5.3% of the total population over 21 in Terrell County) appear. In December 1966, 45 persons were drawn for grand jury duty, including seven Negroes and two females. Of these persons 53.3% had previously been drawn for grand jury duty between 1956 and 1964.

Chart K shows the names of all persons drawn for grand jury duty between August 1956, and December 1966, and the terms of court for which they were drawn. This chart was derived from the Minute Books of the Superior Court of Terrell County. It follows the same form as Charts I and J.

1/ No information was available for the summer 1958, fall 1959, and summer 1964, terms of court. Thus, these figures and Chart K do not include names drawn for grand jury duty during those terms of court.
