

FINAL JUDGMENT

THIS MATTER comes before the Court on (i) the Stipulation of Dismissal of All Claims Against Thomas C. Havel, individually, and as Administrator of the San Juan County Detention Center, and Caroline Conner, in Cause No. 1:15-cv-00417 JB/LF, filed on September 30, 2016 (Doc. 373)(“Salazar-Havel Dismissal”); (ii) the Court’s Order of Partial Dismissal of Plaintiff’s Claims Against All Defendants, filed on February 25, 2016 (Doc. 249)(“SJRMC Federal Claims Dismissal”); (iii) the Court’s Order Granting Stipulated Motion for Dismissal with Prejudice of Defendants Dr. Eric Ketcham and Cindy Ketcham, filed on September 30, 2016 (Doc. 381)(“Ketcham Dismissal”); (iv) in the Court’s Order Granting Stipulated Motion for Dismissal with Prejudice of Defendants Yvonne Valles, RN and Ramona Howard, RN, filed on September 20, 2016 (Doc. 380)(“Valles-Howard Dismissal”); (v) the Stipulation of Dismissal with Prejudice, filed on September 30, 2016 (Doc. 377)(“Nyman Dismissal”); and (vi) the Court’s Order Approving Settlement (Doc. 361)(“Salazar Settlement Order”). In the Salazar-

Havel Dismissal, the parties stipulated to the dismissal with prejudice of all claims made against Defendant Thomas C. Havel, individually, and as Administrator of the San Juan County Detention Center, and Caroline Conner, in Plaintiff's Complaint and in Plaintiff's First Amended Complaint. See Salazar-Havel Dismissal at 2. In the SJRMC Federal Claims Dismissal, the Court ordered that all asserted claims against all Defendants under the Americans with Disabilities Act of 1990, 42 U.S.C. § 12101, and all asserted claims for declaratory and injunctive relief were dismissed with prejudice. See SJRMC Federal Claims Dismissal ¶¶ 1-2, at 1. In the Ketcham Dismissal, the Court ordered that all claims asserted against Defendant Dr. Eric Ketcham and Defendant Cindy Ketcham were dismissed with prejudice. See Ketcham Dismissal at 1. In the Valles-Howard Dismissal, the Court ordered all claims asserted against Defendants Yvonne Valles and Ramona Howard as dismissed with prejudice. See Valles-Howard Dismissal ¶¶ 1-2, at 1. In the Nyman Dismissal, the Court ordered all claims asserted against Defendant Courtney Nyman as dismissed with prejudice. See Nyman Dismissal at 1. In the Salazar Settlement Order, the Court approved the settlement reached between Plaintiff Olga Salazar and the Defendants.

IT IS ORDERED that: (i) final judgment is entered; and (ii) the case is hereby dismissed with prejudice.
