At this morning's status conference, the Court inquired as to the status of the January 27, 2017 Executive Order. To the extent there remains any uncertainty with respect to the January 27 Order, and as explained in Section 13 of the new Executive Order Issued on March 6, 2017, the January 27 order "is revoked as of the effective date of this order." Section 14 of the March 6 Executive Order specifies that the "order is effective at 12:01 a.m., eastern daylight time on March 16, 2017." Thus, the new order revokes the old order as of 12:01 a.m. on March 16, 2017. No further action is necessary for that revocation to occur. *See also* Defendants' Notice of Replacement and Revocation of Executive Order, filed with this Court on March 7, 2017 (ECF No. 51, 1 (new order "will not take effect until March 16, 2017" and "[i]t revokes Executive Order 13,769"). Of course, sections 3(c), 5(a), 5(b), 5(c), and 5(e) of the old executive order remain inoperative and subject to this Court's injunction in *Washington v. Trump*, No. 17-41 (W.D. Wash.).
