MOTION TO DISMISS COMPLAINT

UNDER RULE 12

Now come Defendants, RICHARD B. OGILVIE, Governor of the State of Illinois, WILLIAM F. CELLIANI, Director of the Department of Public Works and Buildings of the State of Illinois, RICHARD H. GOLTERMAN, Chief Highway Engineer of the Division of Highways, Department of Public Works and Buildings of the State of Illinois, and ROBERT E. KRONST, District Engineer, District No. 8, Division of Highways, Department of Public Works and Buildings of the State of Illinois, by their attorney, William J. Scott, Attorney General of the State of Illinois, and move the Court to dismiss the Complaint and strike the action herein against said Defendants, pursuant to the provisions of Rule 12 of the Federal Rules of Civil Procedure, and for an order assessing the costs hereof against the Plaintiffs, and in support of said motion say:

1. Plaintiffs have no legal interest in the property or subject matter of the proceeding alleged in the Complaint and consequently do not have standing to sue.

2. The alleged actions of said Defendants do not violate the Civil Rights Act of 1964 or the 5th or 14th Amendment to the Constitution of the United States.

3. Article III of the Constitution of the State of Illinois prohibits judicial coercion of the Executive Branch of government in the State of Illinois.

4. Section 26 of Article IV of the Constitution prohibits a suit against the State of Illinois.

5. The State of Illinois is not subject to or controlled by the provisions of the Civil Rights Act of 1964.

6. Plaintiffs have failed to state a claim upon which relief can be granted against these Defendants.
