8 On October 12, 2017, in response to Plaintiff City of Los Angeles' ("Los  
9 Angeles") Application for Preliminary Injunction (D.E. 7) against the Department of  
10 Justice's unauthorized use of illegal immigration considerations in awarding community-  
11 oriented policing ("COPS") grants, Defendants disclosed for the first time that the  
12 Department of Justice's Office of Community Oriented Policing Services ("COPS  
13 Office") has putatively determined that Los Angeles' award application was unaffected  
14 by the inclusion of immigration-related considerations. *See* Decl. of Andrew A. Dorr,  
15 D.E. 33-1, ¶ 32. Although Defendants have not included sufficient supporting  
16 information to enable Plaintiff to assess this claim, Plaintiff has concluded that it would  
17 be impractical to explore the matter further and still secure timely relief in advance of the  
18 award decisions for the current grant year. As a result, there is no longer an urgent need  
19 for the relief sought in Plaintiff's Application for Preliminary Injunction.


20 Accordingly, Plaintiff City of Los Angeles hereby withdraws its Application for  
21 Preliminary Injunction (D.E. 7). Because Defendants have not indicated that they will  
22 abandon reliance on unlawful considerations in administering the COPS grant program,  
23 Plaintiff's claims and request for permanent relief remain unaffected.
