NOTICE OF APPEAL

NOTICE IS GIVEN THAT ABOVE-STYLED MOVANT/PROPOSED INTERVENOR WAHEEM DAKEH INTENDS TO APPEAL TO THE UNITED STATES COURT OF APPEALS FOR THE ELEVENTH CIRCUIT FROM THIS COURT'S SEPTEMBER 15, 2017 ORDER (DOC. 103) DENYING HIS MOTION FOR INTERVENTION (DOC. 80), WHICH IS IMMEDIATELY APPLICABLE PURSUANT TO 28 U.S.C. § 1291.

"IMMINENT DANGER OF SERIOUS PHYSICAL INJURY" ("I.D.O.S.P.I.")

ALTHOUGH MR. DAKEH CONTENDS THAT HE DOES NOT HAVE THREE STRIKES AND THAT THE P.L.A. "THREE STRIKES" POLICY IS UNCONSTITUTIONAL, HE NEVERTHELESS QUALIFIES FOR "IN FORMA APPENDIX" ("I.F.A.") STATUS ON APPEAL PURSUANT TO THE "IMMINENT DANGER OF SERIOUS PHYSICAL INJURY" ("I.D.O.S.P.I."), EXCETPTION TO 28 U.S.C. § 1915(g) BECAUSE UN TREATMENT AND ITS RESULTING PLACEMENT ON TIER, HE IS EXPOSED TO THE FOLLOWING FORMS OF I.D.O.S.P.I.: (1) HE IS BEING DENIED INEQUATE FOOD AND NUTRITION AND LOST 30 POUNDS; (2) HE IS BEING DENIED MEDICAL CARE AND UNREASONABLY DELAYED MEDICAL CARE; (3) HE IS BEING DENIED DENTAL CARE FOR TWO MONTHS AND PAIN; (4) HE IS BEING DENIED SANITATION AND HAS SUFFERED FOUR(4) SINUS INFECTIONS; (5) HE IS BEING EXPOSED TO FECES IN THE DORM AND FROM OTHER PRISONERS WHO PROTECT FECES IN THE DORM AND HAS SUFFERED FOUR(4) SINUS INFECTIONS; AND (6) HE IS BEING DENIED OUTSIDE EXERCISE.
