#### **AGREED ORDER**

WHEREAS on June 27, 2016 the Court entered an order granting in part Plaintiffs' motion to reopen this matter to address certain sections of House Bill 1523 and directed the parties to meet and confer on related issues [Dkt. 52];

WHEREAS on June 30, 2016 the Court entered an order in *Campaign for Southern Equality* v. *Bryant*, 3:16-cv-442 ("*CSE IV*") enjoining the enforcement of House Bill 1523, and the Court's preliminary injunction in *CSE IV* is currently the subject of consolidated appeals pending before the United States Court of Appeals for the Fifth Circuit, Cause No. 16-60477;

WHEREAS on August 12, 2016 the Fifth Circuit denied a stay pending appeal of this Court's preliminary injunction in *CSE IV*;

WHEREAS House Bill 1523 remains enjoined in its entirety pending resolution of the merits of the consolidated appeal in Fifth Circuit Cause No. 16-60477;

## THEREFORE IT IS HEREBY ORDERED that this action is stayed.

Within thirty (30) days of the Fifth Circuit's issuance of its mandate in the consolidated appeals in Cause No. 16-60477, the parties will meet and confer and submit to the Court a proposal for how to proceed in this action, consistent with this Court's June 27, 2016 Order [Dkt. 52].
