L. c. 211, 3, seeking review of a bail order set in the District Court. The order reduced the defendant's bail from \$250.00 to \$200.00, based on asserted facts suggesting that the defendant has the financial ability to post bail in this amount using the funds accessible from her canteen account, even assuming that she must pay a bail commissioner's fee of \$40. See affidavit of Norma Wassel, par. 5. Thus, as to this defendant, the bail issue is moot insofar as her claim is that bail was set without regard to her financial ability to post bail. I am mindful, however, that the defendant's petition raises constitutional issues that are potentially significant and that she has filed a motion to enlarge and modify relief, which appears to seek declaratory relief on behalf of a class of similarly situated defendants. I am not yet persuaded, however, that this case is in a suitable posture to be reserved and reported to the full court, although I am not ruling out that possibility. As drafted, the petition is in the form of an appellate brief, detailing the arguments supporting the defendant's claim that setting bail without regard to a defendant's ability to pay is unconstitutional. It lacks a statement of facts on which the court could rely in making such a determination, ignoring the principle that constitutional issues are not decided in the abstract. Given the potential gravity of the constitutional issue, the defendant is granted leave to file an amended petition within thirty days. The petition should be in the form of a typical pleading not written as an appellate brief, as it is now with numbered factual allegations and identifiable causes of action to which the Commonwealth will be able to file an answer. It will be up to the defendant and her counsel to decide whether, in these circumstances, to seek systemic relief in behalf of a class of similarly situated defendants even though this case is now moot. We recommend that the Court refer the matter to the Committee with a request that the Committee issue guidance that will ensure that no defendant is detained pending trial solely because he or she lacks the financial resources to post bailIn light of all the considerations referenced above - including the important statutory and constitutional questions raised by the Amended Petition, the significant consequences of pretrial detention for all involved, the issues regarding justiciability and the scope of the record, and the benefits of a thorough rulemaking process - the Attorney General suggests that this matter be referred to the Standing Advisory Committee on the Rules of Criminal Procedure to consider the issue of a defendant's ability to pay in setting cash bail pursuant to G. L. c. 278, 58." filed.
