AGREED ORDER ON DEFENDANTS' MOTION TO COMPEL

- All Intervenors will continue to produce subsequent employment, tax and wage information as well as all medical records responsive to Defendants' requests for production.
- Intervenors will supplement their discovery responses in accordance with the Federal Rules of Civil Procedure.

This Court, therefore, GRANTS Defendants' Motion to Compel and ORDERS the Intervenors to comply with this agreement.
